WAIVER OF LIABILITY

3. This agreement does not serve as a release or waiver of any claims for any injury resulting from the willful, wanton, reckless, or intentional misconduct of Bicycle Speed Shop, their/its officers, directors, agents, servants, or employees.

4. If any portion or term of this agreement is held or determined to be void, unenforceable or invalid, then such portion or term shall be severable from the agreement and it shall remain in full force and effect.
